# IAPA Announces 2007 Excellence Awards

Ashwin A. Patkar, MD
Outstanding Academician
Award



Dr Ashwin Patkar is currently an Associate Professor of Psychiatry and Medical Director of Duke Addictions Program at Duke University Medical Center, Durham, NC. Dr Patkar earned his medical degree from G S Medical College in Bombay, India, his MRCPsych from the Royal College of Psychiatrists, England and Neuropharmacology degree from University of Nottingham, England. He completed his psychiatry residency at Thomas Jefferson University, Philadelphia and was the Director of Biological Psychiatry and Clinical Trials at Thomas Jefferson University. He is Board Certified with the American Board of

Neurology and Psychiatry with subspecialty Certification in Addiction Psychiatry and American Society of Addiction Medicine (ASAM) Certification in Addiction Medicine.

Dr Patkar's focus of research is translational research in addictions. He has been awarded NIH (NIDA) grants to investigate genetic and biological markers of substance abuse. He is the Co-Principal Investigator of the North Carolina Node of the NIDA supported Clinical Trials Network that aims to bring science based medicine into clinical practice and a Co-Investigator on a National Institute on Alcohol and Alcoholism grant to address rural underage drinking. Dr Patkar is involved in SAMHSA supported services and outcome research focusing on patients with co-occurring disorders, and HIV/hepatitis C.

Dr Patkar has published over 80 peer reviewed articles and book chapters and has given over 150 presentations and invited lectures at national and international meetings. He has received the American Academy of Addiction Psychiatry Research Award, the Lilly Biological Psychiatry Fellowship Award and has served on NIH review committee and Advisory Boards for Industry. He is a member of the Addictions Committee of the North Carolina Psychiatric Association and active in the Indian American Psychiatry Association.

Chaitanya V Haldipur, MD Exemplary Public Sector Psychiatrist



Chaitanya V Haldipur, MD has served his entire career in the public sector, first for 16 years at Hutchings Psychiatric Center- where he rose to be Medical director and now for 17 years at the VA, where he has been Chief for over a decade. as his clinical career in public psychiatry. He was awarded the national APA's Nancy Roeske Award, the President's Award for Excellence in teaching and has just been nominated for the SUNY-wide Chancellor's Award for Excellence in Teaching.

He has kept a steady pace in writing and some of his work (with Glassner) has been seminal in the field. Relevant to IAPA, he is an expert in the history of Psychiatry in India. His papers titled "Psychiatric nosology and Classification in Ancient India" and "Madness in ancient India" are classics and clearly challenge Fuller Torrey's assertion that schizophrenia is a relatively 'modern disease', an argument he makes to support his viral hypothesis. Overall, Chetan is a scholar and a gentleman who is as fine and accomplished an example of a public sector psychiatrist as you can find.

# Shastri Swaminathan, MD Outstanding Service Award



Dr. Shastri Swaminathan is Medical Director, Department of Psychiatry, Advocate Illinois Masonic Medical Center and Clinical Associate Professor, University of Illinois. He is one of those multi-faceted psychiatrists who serve in many fields and shine in each. Dr. Swaminathan who is a distinguished fellow of or the American psychiatric Association has served on several committees on governmental affairs, private practice psychiatry and religion. He was credited by APA as the lead of the coalition was successful passage of mental health that parity legislation in Illinois. He has served as the president of Illinois Psych Society and in that role was successful and defeating psychologist prescribing bill.

Dr. Swaminathan has also been active in Illinois State Medical Society. Currently he is their President-elect. He has served as the trustee, as well as the alternate delegate for Illinois in the House of Delegates of the American Medical Association. He has been a pivotal force in campaigning for rights of international medical graduates. He spearheaded an initiative that repealed an onerous section of Illinois medical practice act discriminating against international graduates entering residency.

As the chair of AAPI-PAC, he worked to ensure passage of the historic IMG anti-discrimination legislation in the U. S. Congress. He was a member of the steering committee that successfully campaigned for the creation of the IMG section of the AMA. In addition to his contributions to the profession Dr. Swaminathan is also active in the Indian community. He is the chairman of the India forum. He is advisor to many community organizations which include Indo crisis line, Apna Ghar, and the Indo American center.

Throughout his career he has received numerous awards including, Dynamic leadership award- International medical council and India Medical Association; Presidential award for outstanding legislative activities and liaison to organized medicine; Golden Apple award for excellence in medical student teaching at the University of Illinois and Metro 6 hospitals; and the APA Nancy Roeske award for excellence in teaching.

In summary Dr. Swaminathan's dedication to the field of psychiatry and international medical graduates is laudable and deserves recognition by the IAPA.

# Gagandeep Rajee Singh, MD Outstanding Resident Award

Dr. Gagandeep "Rajee" Singh is currently a third year General Psychiatry Resident at University of Medicine and Dentistry of New Jersey - Robert Wood Johnson Medical School (UMDNJ - RWJMS), and will be entering his Child and Adolescent fellowship training at the same school in July, 2007.

He was born in Delhi and came to America just before 2 years of age. He has lived in New Jersey since the age of seven. He is a graduate with Honors of Rutgers University, which he attended as a Goldstein Scholar. Dr. Singh received his M.D. from UMDNJ - RWJMS in 2004. His easy going personality and sense of humor are among his endearing qualities.

As a Psychiatry Resident, he has had an outstanding clinical record. He is focused, energetic, and intelligent. Dr. Singh has been committed towards cultivating his academic and



research interests. Last year, Dr. Singh was the recipient of a 'Best Paper' Award from the New Jersey Psychiatric Association, for a case report on Internet Addiction which is being considered for publication at this time. He will be presenting a poster on "The Prevalence of Osteoporosis in Patients with Severe and Persistent Mental Illness" as a young investigator at the 2007 APA convention in San Diego. He is also working on research involving "Teenage Coping Strategies in Response to Stress of Conflict."

While he has been raised here, Dr. Singh feels a deep connection to his roots. He identifies his values as "Indian" and chooses to lead a more traditional lifestyle, including a future 'joint-family' home-life. As a Sikh who maintains an untrimmed beard and wears a turban, he has always stood out and has used this to his advantage to educate others about Indian and Sikh culture. Dr. Singh has dedicated his time and effort towards himself understanding, and otherwise expanding others' knowledge, regarding Indian culture. This has been manifested over the course of his undergraduate and medical school careers via board positions in numerous cultural organizations, as well as through organizing and participating in a multitude of cultural programs during that period.

Also in this vein, Dr. Singh has recently become involved with the North American Sikh Medical and Dental Association (NASMDA). In a short span of time, he has gone from a general member to founding and being asked to be president of the early career physicians' subchapter of this organization (NASMDA-FRAMS). Dr. Singh is currently in the process of recruiting his board members for NASMDA-FRAMS.

Dr. Singh's dedication to medicine and psychiatry has been met with equal fervor for his cultural and religious background, and he has been able to realize goals in these realms over the last decade. # Dr. Dilip V. Jeste invited to join Institute of Medicine.



Dr. Dilip Jeste was among 65 new members invited to join the Institute of Medicine, one of the highest orders for medical professionals in the United States. Dr. Jeste a distinguished Professor of psychiatry and neurosciences at the University of California, San Diego, was selected for his contributions to medical science. IOM president Harvey V. Fienberg stated that members are elected through a highly selective process and recognized for their major contributions to the advancement of the medical sciences, healthcare, and public health. Establish in 1970 under the charter of the National Academy of Sciences, the Institute provides independent, objective, evidence based advice to policymakers. The Secretary of Health and Human Services recently asked Dr. Jeste to serve on the national advisory mental health counsel of America's National Institute of Health another very prestigious appointment.

Dr. Jeste stated that he was very proud to be the first psychiatrist of Indian origin, to be selected to the IOM and the to the national advisory mental health counsel.

Dr. Dilip Jeste also serves as the Estelle and Edgar Levi Chair in aging, and is director of the Sam and Rose Stein Institute for research on aging. An internationally known researcher in geriatric psychiatry, Dr. Jeste is Chief of the UCSD division of Geriatric Psychiatry and a Geriatric Psychiatrist with the Veterans Affairs San Diego healthcare system. He came to the US after getting his medical degrees from Pune and Mumbai and completed his psychiatry residency at Cornell University and neurology residency at George Washington University. The Institute of scientific information lists him as one of the world's most cited authors of the last two decades. He is a former president of the American Association of Geriatric Psychiatry and the founding president of the International College of Geriatric Psychoneuropharmacology. He serves as the Editor-in-chief of the American Journal of Geriatric Psychiatry. He is listed in the best doctors in America and is the recipient of numerous awards.

Nalini Juthani, MD is a Professor of Clinical Psychiatry at the Albert Einstein College of Medicine (AECOM) in New York. She was the Residency Program Director and Assistant Dean for Undergraduate affairs at the Bronx Lebanon Hospital Center for 25 years. In addition, she serves on the Admissions and Promotions Committees of AECOM. She has recently joined the Accreditation Council for graduate Medical Education (ACGME) as an Accreditation Representative.

Dr. Juthani is a diplomat of the American Board of Psychiatry and Neurology (ABPN) and she has served as a Board Examiner for 10 years. She was also appointed as a member of the Residency Review Committee (RRC of Psychiatry ACGME). She has served on the Executive committee of the American Association of the Directors of Psychiatric Residency Training (AADPRT) and is a Distinguished Fellow of the American Psychiatric Association (APA). She has received numerous awards in the field of psychiatry education, Religion and Psychiatry to mention a few.

Dr. Juthani's notable contribution is to the education, mentorship and development of IMGs . During her tenture as a psychiatric program director and assistant Dean at Bronx Lebanon Hospital she has trained 125 IMGs from all over the world and 500 medical students from Albert Einstein College of Medicine. She has led conferences for IMGs on "How to become a competitive applicant for Psychiatry Residency training" APA, having recognized her contributions as a notable IMG educator appointed her to the RRC Psychiatry. Currently at the ACGME level she is one of the few female and the first Asian to have been appointed as a Field representative that provides accreditation site visits to residency training programs all over the US. Dr. Juthani was a Finalist for Parker J. Palmer, Courage to Teach award given by ACGME.

Dr. Juthani was the first elected president of the IMG caucus of the Assembly of the APA. She has served on numerous components of the APA including the IMG, Religion and Psychiatry, Minority and underrepresented, Administrative Psychiatry and management and she was appointed to the Task force on Strategic Planning of the APA by the president of the APA. She is currently serving her second three year term on the Advisory Board of Psychiatric News. In each of these appointments she has represented IMGs, females and the Asian psychiatrists. She was the president of Indian American Psychaitric association for two year term. During this tenure she established an outstanding resident award which IAPA gives out every year.

She has presented on IMG and culture related topics at the APA for over two decades. She has made numerous presentations on the Topic of Religion, Spirituality and Mental Health. She is author of several publications, of note are a chapter entitled "Understanding and Treating Hindu Patients" in the Handbook of Religion and Mental Health edited by Harold Koenig and an article entitled "Challenges Faced by International Women Professionals" published in Academic Psychiatry, 28:4, winter 2004

# AAGP Distinguished Scientist Award for Dr. K. Ranga Rama Krishnan





# Indian Philosophy, Modern Psychiatry and Mental Health

One weekend, while attending a social function at a New York Hindu temple, we met a long time acquaintance who shared with us the recent death of his forty-year old son to heart disease. When we began to offer our regrets and condolences, he replied, "It's okay. It's part of life. We all have to go sometime." His countenance was calm, not without signs of love lost, but peaceful nonetheless. We couldn't help but discuss our interaction with this man and the untimely tragic loss of his only son, who left behind a wife and two daughters. We were both struck by his reply. Should this man offer such an answer in the context of psychoanalytic or psychodynamic therapy, the therapist may categorize his reply as employing psychological defenses, particularly intellectualization or rationalization and as someone who had not fully worked out his grief issues. One aspect of the therapy may then focus on interpreting these defenses at some point in the future. But it seemed to us that this man was seeking comfort in something other than his defenses. He shared with us that he regularly attended the temple services and that they provided him with the necessary tools to deal with his son's death. He was not the first person in our community of Indian immigrants and their children who had expressed this idea. There were countless family friends who struggled with illness, death, and economic troubles who found that their temple attendance had provided them with the answers to their most difficult questions. We became curious to understand the message that was offered to them and in what ways was this process similar or different to modern psychiatry. We then decided to embark on a seven-day inquiry by attending temple services each evening for one week to help elucidate the mystery and power that lay in Indian philosophy.

The study of spirituality and its impact on mental and physical health has gained popularity in recent years in medical communities and lay public alike. A 2002 Mayo Clinic review found that overall, religious involvement and spirituality are associated with better coping skills, decreased morbidity and mortality, less depression, anxiety, and suicide. There is a growing interest in psychiatry and other branches of medicine in the area of spirituality as most surveys show that 90% of people believe in a higher power. These issues, appealing to the mass media, have graced the covers of many national magazines including one November 10, 2003 Newsweek magazine cover, "God and Health: Is Religion Good Medicine? Why Science is Starting to Believe." Spirituality and Psychiatry are learning from each other.

In an attempt to better conceptualize Indian philosophy and its impact on mental health, we decided to attend 7 nights of services at this temple. Annually, a well-known speaker/guru delivers a service each night including bhajans (songs of workshop) weaved with mythology and philosophy. There were certain key ideas, although not meant to be a complete, that we distilled from our experience.

1) Why do many South Asians turn to the temple as opposed to formal mental health services?

It appears that there is a pervasive stigma against seeking help for mental health, not only in the South Asian community, but present in many minority cultures. Furthermore, a lack of awareness of resources, skepticism, and mistrust in allopathic medicine are some key reasons. Moreover, many Indian immigrants do not have health insurance or the economic means to access and utilize mental health resources. And lastly, for many Indians, philosophy and religion not only provide them with an outlook on life, but also as a way to gather as a community. These individuals have often received comfort and solace in time of need. Issues of isolation from the parent country may further the drive to return to familiar settings including the temple.

2) Does Hindu philosophy address the mental health needs of these individuals and if so, in what way is it similar to modern psychiatry? How is it different?

Both traditional Hindu philosophy and modern psychiatry recognize that human conflict is the cause of psychological distress and that it can manifest as psychological or physical symptoms. They both offer a framework to conceptualize this distress in order to alleviate it.

According to psychoanalytic theory put forth by Freud, the underlying cause of conflict stems from the id, the pleasure principle, and its struggle with the superego and mediating ego. Repression of the id, and its sexual and aggressive impulses, begins to manifest as psychiatric symptoms. Defenses then develop to help modulate the incessant desires and to allow the individual to continue to function.

Similarly, in Hindu philosophy, there is an emphasis of the concept of desire or "Thrishna" and its stronghold of the senses. The Bhagavad Geeta (literally "The Divine

Song") is considered one of the religion's major sacred texts and possibly the world's longest epic poems with 700 Sanskrit verses. More importantly, in its 18 sessions, it can also be considered the world's first documented psychotherapy. The Bhagvad Gita portrays the story of the warrior Arjuna who was faced with a great moral dilemma: to wage war against his nefarious family in the service of justice. Paralyzed with fear, he is unable to act. Krishna, his charioteer, trusted friend and sage, identifies Arjuna's central conflict as one of desire and attachment and to his loved ones, his pride, and the outcome of the war. It is this desire to win that is causing Arjuna's psychological symptoms, war neurosis or a DSM-IV-TR categorized panic disorder. Arjuna begins to understand the conflicts before him. He is not the only one at war- but rather the larger concepts of dharma and thrishna are at battle-should he pay attention to his duty or to his desires? This parallels the intrapsychic conflict between one's superego and id as put forth in Freud's structural model

Also similar in both Indian philosophy and psychodynamic therapy is the idea of trust. When entering a therapist's office or the temple, a certain amount of trust is implicit in each case. Moreover, both can be considered an act of submission. Lying down on a couch in the analyst's office or sitting on the floor, with shoes removed in a temple, both require a certain amount of surrender and trust to an authority figure (the guru, the therapist or even God).

Although there are many differences between Indian philosophy and Psychodynamic therapy, a few that were most apparent to us were:

- 1) Who is the patient? Psychodymanics, for the most part, emphasizes the development and appreciation of the individual in the context of the family and society (barring group and family therapy). The relationship is between therapist and individual. It is this relationship and transference that will be the basis for much of the work and healing that is done. Indian philosophy is addressed to the masses and is conducted in large groups. The family unit, not the individual, is the basic unit of Indian society.
- 2) Which time period in a person's life is most relevant? The emphasis in psychoanalytic theory is on the past and the various stages of psycho-sexual development. Indian philosophy is present and future oriented.
- 3) What is the theoretical framework? Psychodynamic theory and modern psychiatry comprises a classification system

of disease states and syndromes. Indian philosophy, mainly focused on prevention does not address and classify various disease entities according to symptoms. It is not equipped to treat a severely and persistently mentally ill person. Indian philosophy does postulate the concept of "sanskar" which acknowledges nature and nurture, but does not detail biological influences.

4) What is the aim? According to Freud, the picture of mental health is to be able to "work and to love". Psychodynamic treatment seeks to understand an individual's dysfunction and attempts change through interpretation of the transference as well as the defenses employed by the individual. Ideally, immature defenses are replaced with healthy, mature ones leading to clarity and hopefully, resolution of presenting symptoms.

Indian philosophy, is also interested in restoring an individual back to function. However, it does not stop there. Indian philosophy, seeks to make the functional person exceptional through recognition of ones "true nature". According to this idea, most individuals live in 'Samsara' or in ignorance of their infinite potential and that they are constrained by 'maya' or illusion. Various paths can be taken to achieve 'moksha' or liberation from maya which produces desire and attachment, the cause of suffering. Krishna revealed to Arjuna the solution to his suffering by teaching him that through any of the four pillars of voga, one can achieve 'Moksha' or liberation from suffering. He highlights the impermanence of the material world, and attachment to it, as the cause of suffering. The four paths to happiness lay through Karma (duty), Ghyana (knowledge), Dhyana (meditation), and Bhakti (devotion and love). According to the Gita, only through detachment from our material ego, the "False self ", can we truly be happy.

In summary, both Indian philosophy and psychodynamic theory provide a rich understanding to the human psyche. They both recognize conflict emerging from the battle between desire and moral duty and aim to alleviate the inner turmoil that is produced as a result. Although the theoretical framework and methods by which they aim to cure the "neurosis" of the individual differ, they can be complementary. As mental health workers, it is of paramount importance to be savvy about not only of our patient's cultural and religious framework but to be able to tap into our own values as they serve to further equip our armamatorium of techniques in service of healing our patients should they be open to them.
