#### Stanley Dean Award 2016

The Stanley Dean Award is a prestigious award for research in schizophrenia by the American College of Psychiatrists in recognition of Stanley R. Dean.

In the autumn of 1957, Stanley R. Dean proposed the creation of a foundation on schizophrenia to a group of friends. Its purpose was to free schizophrenia from the shameful anonymity in which it was buried. Stanley Dean recognized the importance of this illness from a public health

perspective. He was determined to bring light to it during his lifetime.

In December 1957, a decision was made to create an organization called Research in Schizophrenia Endowment (RISE). Within two months, articles for the incorporation for RISE were issued by the State of Connecticut. By the end of March 1958, Dr. Dean was successful in convincing Congress to provide \$1,300,000 for research in schizophrenia. This was the first time that Congress had allocated funds specifically for research on this disorder. He was instrumental in convincing Congress to increase its appropriation to the National Institute of Mental Health (NIMH) by more than \$8,000,000 by April 1969. It was specified that approximately one-half of the total research funds to the NIMH be used for projects related to schizophrenia. In the spring of 1960, RISE relinquished its corporate charter and became an integral part of the Research Foundation of the National Association for Mental Health.

Dear Dr. Viswanathan,

On behalf of the American Psychiatric Foundation and the Award Selection Committee, I am pleased to inform you that you have been chosen as the recipient of the 2016 George Tarjan Award. Named after APA's first international medical graduate (IMG) president, the George Tarjan Award, established in 1992, recognizes a physician who has made significant contributions to the enhancement of the integration of IMGs into American

psychiatry. We strongly feel that your commitment and contributions to improve integration of IMGs into psychiatry make you an outstanding recipient of this award. We hope that you will accept this honor. The award includes a \$500 honorarium, an engraved plaque, and an honorary lecture to be presented at the APA Annual Meeting in May 2017. Please note that the APA is unable to cover your travel expenses to the award ceremony.

As preparations are made for the 2016 meeting we will need some material from you, including a 150-200 word biographical sketch, a 3x5 black and white photograph, and a brief abstract of your upcoming lecture. This material will be used in the Annual Meeting Convocation Program Book as well as for publicity in conjunction with the award.

#### Pride of our Association: Harsh K. Trivedi, MD; MBA



It is a privilege and pleasure to share the success story of a distinguished IAPA member and the pride of our Association – Harsh K. Trivedi, MD, MBA. In June of 2016, Dr. Trivedi became the President and Chief Executive Officer of the prestigious Sheppard Pratt Health System (the largest private, non-profit provider of mental health and substance use services in the U.S).

Formerly, Harsh served as the Chief Executive Officer of Vanderbilt Psychiatric Hospital and the vice chair of clinical

affairs in Vanderbilt University's department of psychiatry. A graduate of the Mount Sinai School of Medicine, Dr. Trivedi went on to complete his residency in general psychiatry at the Zucker Hillside Hospital of the Albert Einstein School of Medicine. He then became a Congressional Health Care Fellow and worked with U.S. Senator Jack Reed (D). During this period, he crafted the Campus Care and Counseling Act (S.2215/H.R.3593) which was signed into law in 2006. It has served to provide \$160 million for youth suicide prevention programs and expanded mental health services on college campuses (part of the Garrett Lee Smith Memorial Act).

Harsh completed his child and adolescent psychiatry training at the Boston Children's Hospital of Harvard Medical School. He has served as the director of adolescent services and the site training director at Bradley Hospital and as assistant professor of psychiatry at Brown University.

Currently, Harsh holds a leadership position on the governing council of the American Hospital Association, chairs the Council on Healthcare Systems and Financing for the American Psychiatric Association, and represents the field of psychiatry in the American Medical Association House of Delegates. He is active in the American Academy of Child & Adolescent Psychiatry and is a member of the American Association for Physician Leadership.

Harsh has served as the consulting editor of the Child and Adolescent Psychiatric Clinics of North America since 2008. He is a reviewer for the Journal of the American Academy of Child and Adolescent Psychiatry, and has co-authored several books, book chapters and articles. Harsh has been awarded the American Medical Association Foundation Leadership Award, the American Psychiatric Foundation Spurlock Congressional Fellowship Award, and the American Association of Directors of Psychiatric Residency Training Ginsberg Award.

In 2003, the IAPA recognized signs of Dr. Trivedi's exceptional talent and he was honored with the Outstanding Resident Award. His laurels only attest to his distinction and merit. During his tenure at Vanderbilt University, Harsh admirably and actively served Tennessee Chapter of the IAPA.

We congratulate Harsh for his hard-earned success and wish him and his wife, Urmi, and their sons, Amar and Aarav, the very best.

#### Abstract Submission for the 2017 Scientific Conference

The Scientific Committee of the IAPA is currently seeking applications from residents, fellows and early career psychiatrists (ECPs) of Indian origin to present at the Annual IAPA Conference on **Sunday, May 21<sup>st</sup> in San Diego, CA.** The theme of this year's conference is "Geriatric Psychiatry, Wisdom, and Aging," however abstracts pertaining to all topics in psychiatry will be given equal consideration for acceptance and awards.

The submitted application should include the authors' names, official address, telephone number, email address and a scientific abstract of their unique clinical or research work. The abstract should be limited to 750 words, and should include a description of the objectives, methods used, results, conclusions, and at least two pertinent references. The authors should also indicate whether they would prefer to do an oral or a poster presentation. **All applicants should be members of IAPA.** Abstracts that have been presented at other conferences within the last year may also be submitted. The top three abstracts chosen by the IAPA Scientific Committee will receive awards.

Applications should be emailed to both Drs. Neeral Sheth (<u>Neeral.Sheth@gmail.com</u>) and Tanuja Gandhi (<u>drtanujagandhi@gmail.com</u>) with subject titled "IAPA Abstract Submission [Full Name]." Please direct any questions to them.
